Please read the full set of rules available at www.nasashootingsports.com: **FULL compliance with all Federal, State, and local laws and those of our insurance carrier.** Exhibitor set up hours are on Friday from 10:00am until 6:00 p.m. Saturday morning set up is from 7 a.m. until 8:30 a.m. and Sunday set up is at 8:00 a.m. At 8:30 a.m. we begin securing the move in doors for opening. We do not hold unpaid tables past 8 a.m. Saturday and do not guarantee unpaid reservations. Table assignments will be given at check in. Tables are \$35. **YOU MAY DEDUCT \$10 PER TABLE IF WE RECEIVE YOUR PAYMENT BY 3/26/2017.** We will do our best to accommodate special requests. Refunds only if cancelled prior to the day of the show. Electricity is \$5 per vendor. Vendors must be open for business each day by 9:00 a.m. and remain open throughout the show hours. Do not tear down your display prior to 2:00 p.m. Sunday. The use of all tables is the property of NASA and may not be sold, transferred or shared without written permission of NASA. Location of table assignments is at the discretion of NASA. All ammunition must be in a container. Our insurance does NOT cover you, get your own. Security coverage will be provided continuously from 10:00 a.m. Friday to 5:00 p.m. Sunday. **LOADED FIREARMS WILL NOT BE PERMITTED IN THE FACILITY WHETHER BY EXHIBITOR OR VISITOR. ALL FIREARMS WILL BE 'ZIP-TIED'.** The 'Zip-Tie' rule will be **STRICTLY** enforced. No pets. Apache County, The City of St. Johns, and Northeastern Arizona Sportsman's Association, Inc. are NOT responsible for loss, damage, or injury. The dealer/exhibitor specifically agrees to defend and hold harmless Apache County, The City of St. Johns, and Northeastern Arizona Sportsman's Association, Inc. from all claims for bodily injury and/or property loss or damage arising out of the dealer's/exhibitor's participation in the show.
